6           **AN ORDINANCE OF THE CITY OF COVINGTON**  
7           **AUTHORIZING THE MAYOR TO EXECUTE AN ACT OF**  
8           **SUBLEASE WITH C. R. RESTAURANT/CAFÉ NO. 1, L.L.C.**  
9           **FOR THE USE OF ITS PROPERTY FOR PUBLIC PARKING**

11           **WHEREAS**, there is a limited number of public parking spaces in the  
12 Division of St. John to accommodate the need for public parking; and

13           **WHEREAS**, additional parking options will provide an economic boost to  
14 business owners and to the City of Covington and the benefits derived far outweigh  
15 the expense; and

16           **WHEREAS**, the Covington City Council deems that the execution of this  
17 Act of Sublease is in the best interest of the health, safety and welfare of the  
18 citizens of Covington; and

19           **WHEREAS**, the Covington City Council has held all public hearings  
20 required of it in accordance with law; and

21           **NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City  
22 of Covington, at its regular session convened, that the attached Act of Sublease  
23 between the City of Covington and C. R. Restaurant/Café No. 1, L.L.C. is  
24 approved and the Mayor of the City of Covington is authorized to execute same on  
25 behalf of the City of Covington.

26           **BE IT FURTHER ORDAINED** that if any provision of this ordinance  
27 shall be held to be invalid, such invalidity shall not affect other provisions herein  
28 which can be given effect without the invalid provision and to this end the  
29 provisions of this ordinance are hereby declared to be severable.

30           **WHEREUPON**, this ordinance having been submitted in writing, having  
31 been read by title and adopted at a public meeting of the City Council of the City

1 of Covington, State of Louisiana, was then submitted to an official vote as a whole,  
2 the vote thereon being as follows:


