**AN ORDINANCE OF THE CITY OF COVINGTON
LEVYING, IMPOSING AND ADOPTING THE SEWERS
& SEWER DISPOSAL WORKS BONDS ON ALL PROPERTY
SUBJECT TO TAXATION IN THE CITY OF COVINGTON,
STATE OF LOUISIANA, FOR THE YEAR 2020**

WHEREAS, Ordinance #2020-13, entitled “An Ordinance of the City of Covington Levying, Imposing and Increasing the Millage Rates on all Property Subject to Taxation in the City of Covington, State of Louisiana, for the Year 2020”, was denied by the Covington City Council on July 21, 2020 (copy attached); and

WHEREAS, Ordinance #2020-13 contained the roll forward of the General Alimony and Fire Protection Facilities millage rates and the levy of the millage rates for the Sewers & Sewer Disposal Works Bonds for the Year 2020; and

WHEREAS, it was the intention of the Covington City Council to deny the roll forward of the General Alimony and Fire Protection Facilities millage rates, but to levy, impose and adopt the Sewers & Sewer Disposal Works Bonds on all property subject to taxation in the City of Covington, State of Louisiana, for the Year 2020.

NOW, THEREFORE, BE IT ORDAINED by the City Council for the City of Covington, Parish of St. Tammany, State of Louisiana, at its regular session convened, that it hereby votes to levy, impose and adopt the Sewers & Sewer Disposal Works Bonds on all taxable property shown on the official assessment roll for the City of Covington, State of Louisiana, for the year 2020, as follows:

2020 Levy

Sewers & Sewer Disposal Works Bonds – 5053 006 3.50 mills

1 **BE IT FURTHER ORDAINED** that the Assessor of the Parish of St.
2 Tammany, shall extend upon the assessment roll for the year 2020 the taxes herein
3 levied, and the Tax Collector of said Parish shall collect and remit the same to said
4 taxing authority in accordance with law.

5 **BE IT FURTHER ORDAINED** that the Covington City Council has held its
6 public hearing in accordance with law.

7 **WHEREUPON**, this ordinance was read in full, the roll was called on the
8 adoption thereof, and the ordinance was adopted by no less than two-thirds of the total
9 membership of the taxing authority voting in favor as required by Article VII, Section
10 23(C) of the Louisiana Constitution and R.S. 47:1705(B). The votes were:
