**AN ORDINANCE OF THE CITY OF COVINGTON
DECLARING SURPLUS PROPERTY OWNED BY THE
CITY OF COVINGTON AND AUTHORIZING THE MAYOR
TO EXECUTE ANY AND ALL DOCUMENTS IN CONNECTION
WITH THE DONATION OF SAID SURPLUS PROPERTY
TO THE ST. TAMMANY PARISH FIRE DISTRICT NO. 8**

WHEREAS, it has been determined that the property described below is no longer needed for the public purposes of the Fire Department for the City of Covington:

1. One (1) Delta Hydro Fire Tester and Rescue 42 Extrication Kit Including Struts, Straps, Ratchets and Pins
2. Super Vac Exhaust Fan
Model 730G4H
Serial No. 4873

WHEREAS, it is the desire of the City Council for the City of Covington to comply with Louisiana state law regarding the disposition of surplus property.

NOW, THEREFORE, BE IT ORDAINED by the City Council for the City of Covington, Louisiana, in regular session convened, that the movable property described above is hereby declared not needed for public use and therefore surplus; and

BE IT FURTHER ORDAINED that said surplus property described above shall be disposed of pursuant to Louisiana Revised Statute 38:2319.21 and the Mayor is hereby authorized to donate such surplus movable property to the St. Tammany Parish Fire District No. 8 and to execute any and all documents in connection with said donation; and

BE IT FURTHER ORDAINED that if any provision of this ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein

1 which can be given effect without the invalid provision and to this end the
2 provisions of this ordinance are hereby declared to be severable.

4 been read by title and adopted at a public meeting of the City Council of the City
5 of Covington, State of Louisiana, was then submitted to an official vote as a whole,
