14           **WHEREAS**, it has been determined that the property described below is no  
15 longer needed for the public purposes of the Police Department for the City of  
16 Covington:

22           **WHEREAS**, it is the desire of the City Council for the City of Covington to  
23 comply with Louisiana state law regarding the disposition of surplus property.

24           **NOW, THEREFORE, BE IT ORDAINED** by the City Council for the  
25 City of Covington, Louisiana, in regular session convened, that the movable  
26 property described above is hereby declared not needed for public use and  
27 therefore surplus; and

28           **BE IT FURTHER ORDAINED** that said surplus property described above  
29 shall be disposed of pursuant to Louisiana Revised Statute 38:2319.21 and the  
30 Mayor is hereby authorized to donate such surplus movable property to the Town  
31 of Abita Springs Police Department and to execute any and all documents in  
32 connection with said donation; and

33           **BE IT FURTHER ORDAINED** that if any provision of this ordinance  
34 shall be held to be invalid, such invalidity shall not affect other provisions herein

1 which can be given effect without the invalid provision and to this end the  
2 provisions of this ordinance are hereby declared to be severable.

3 **WHEREUPON**, this ordinance having been submitted in writing, having  
4 been read by title and adopted at a public meeting of the City Council of the City  
5 of Covington, State of Louisiana, was then submitted to an official vote as a whole,
