INTRODUCTION

ORDINANCE NUMBER 2021-02

**AN ORDINANCE OF THE CITY OF COVINGTON
RENAMING THE STREET KNOWN AS HEBERT LANE,
WHICH STREET IS LOCATED BETWEEN EAST 10TH AVENUE
AND EAST 12TH AVENUE AND EAST OF SOUTH LOUISIANA
STREET AND WEST OF SOUTH NEW HAMPSHIRE STREET,
AS SOUTH VERMONT STREET**

WHEREAS, there are four undeveloped lots of record with frontage on an unimproved Right-of-Way between East 10th Avenue and East 12th Avenue and east of South Louisiana Street and west of South New Hampshire Street that is dedicated as Hebert Lane and that will need to be developed in order to provide access to any future homes; and

WHEREAS, there is already an improved Hebert Lane that is east of the intersection of East Gibson Street and Lee Lane and running parallel to the Tammany Trace, which duplication St. Tammany Parish 911 believes will create confusion on the part of emergency services and may affect the public safety; and

WHEREAS, by analyzing maps of the subject area of the city, it appears that South Vermont Street would naturally extend through the location and a goal of Section 86-10(a) is to maintain the continuity of street names throughout the city; and

WHEREAS, pursuant to the Covington Code of Ordinances, Sec. 86-10(d), written comments from the city's police, fire, and public works departments, along with the Postmaster, and the St. Tammany Parish Communications District ("911") have been requested with no objections received; and

WHEREAS, the City Council has held its public hearing in accordance with law.

1 **NOW THEREFORE, BE IT ORDAINED** by the City Council of the City
2 of Covington, at its regular session convened, that the dedicated right-of-way
3 within Square 12, Wayside Addition, which is between East 10th Avenue and East
4 12th Avenue and east of South Louisiana Street and west of South New Hampshire
5 Street that is dedicated as Hebert Lane shall be renamed “South Vermont Street”.


6 **BE IT FURTHER ORDAINED** that if any provision of this ordinance
7 shall be held to be invalid, such invalidity shall not affect other provisions herein
8 that can be given effect without the invalid provision and to this end the provisions
9 of this ordinance are hereby declared to be severable.

10 **WHEREUPON**, this ordinance having been submitted in writing, having
11 been read by title and adopted at a public meeting of the City Council of the City
12 of Covington, State of Louisiana, was then submitted to an official vote as a whole,
13 the vote thereon being as follows:
