member of the CHDC.

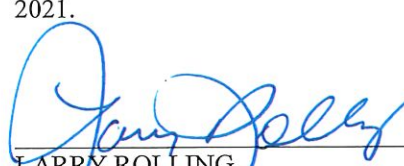
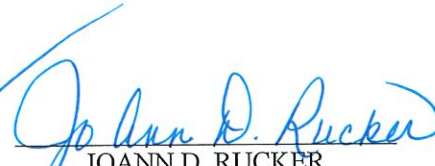
NOW, THEREFORE, BE IT RESOLVED that the City Council for the

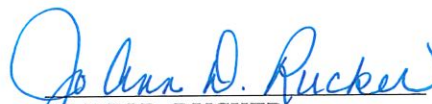
