6 A RESOLUTION OF THE COVINGTON CITY COUNCIL
7 AUTHORIZING THE MAYOR TO EXECUTE A
8 COOPERATIVE ENDEAVOR AGREEMENT WITH ST.
9 TAMMANY PARISH GOVERNMENT FOR THE PURPOSE OF
10 COMPLETING ACQUISITIONS UNDER THE LOUISIANA

15 **WHEREAS**, Parish is sub-grantee of funds, granted to the State of Louisiana,
16 under the Community Development Block Grant – Disaster Recovery and
17 Mitigation/Resiliency Program (the “**Program**”); and

18 **WHEREAS**, certain properties within the corporate limits of City are eligible
19 for the Program; and

20 **WHEREAS**, under the Program, Parish has been awarded Program funding
21 for buyout of seven parcels within the City’s corporate limits; and

22 **WHEREAS**, Parish and City desire to enter into this Agreement to address
23 the rights and responsibilities of administration of the Program within City’s
24 corporate limits.

25 **NOW, THEREFORE, BE IT RESOLVED** that the City Council for the
26 City of Covington at a meeting duly convened, hereby confirms the Mayor to
27 Execute a Cooperative Endeavor Agreement with St. Tammany Parish
28 Government for the purpose of completing acquisitions under the Louisiana
29 Watershed Initiative Grant Program.

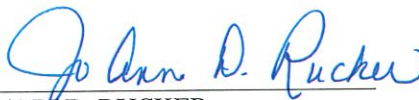
