14 **WHEREAS**, the City of Covington Fire Department entered into an
15 Intergovernmental Agreement with St. Tammany Parish Fire Protection District #1
16 for 9-1-1 Call Taking and Dispatching Services, pursuant to Ordinance # 2018-15;
17 and

18 **WHEREAS**, District 1 has a Communications Division which dispatches
19 fire and emergency calls for multiple agencies; and

20 **WHEREAS**, the City of Covington requires Communication and
21 Dispatching Services and has requested that Fire District No. 1 provide
22 Communications and Dispatching Services to City of Covington; and

23 **WHEREAS**, Fire District No. 1 agrees to provide Communications and
24 Dispatching services for City of Covington and will offer assistance to City of
25 Covington, with maintaining data transfer between the Computer Aided Dispatch
26 System utilized by Fire District No. 1 and City of Covington's Fire Report/Records
27 Management System, and other software while maintaining data integrity and
28 security of City of Covington's data; and

29 **WHEREAS**, the City of Covington agrees to pay Fire District No. 1
30 pursuant to the fee schedule here with as Exhibit A fee schedule:
