8 **A RESOLUTION OF THE CITY OF COVINGTON**
9 **AUTHORIZING THE APPOINTMENT OF AN ASSISTANT**
10 **CITY ATTORNEY FOR LABOR AND EMPLOYMENT**

13 **WHEREAS**, the assistant city attorney for the City of Covington handling
14 labor and employment law matters recently retired; and

15 **WHEREAS**, labor and employment law is a specialized area of the law
16 requiring an attorney well-versed therein; and

17 **WHEREAS**, the City of Covington encounters labor and employment law
18 issues requiring an attorney with such specialized experience; and

19 **WHEREAS**, the Covington Home Rule Charter provides that the Covington
20 City Council may authorize the appointment of an assistant city attorney; and

21 **WHEREAS**, the Covington City Council has determined that the appointment
22 of an assistant city attorney for labor and employment law matters is essential to the
23 efficient functioning of the City;

24 **NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City
25 of Covington, at its regular session convened, that the appointment of an assistant
26 city attorney for labor and employment law matters is hereby authorized and the City
27 Attorney is authorized to make said appointment.

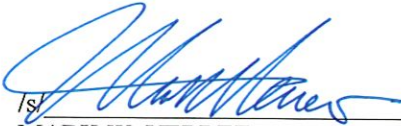
28 **WHEREUPON**, this resolution having been submitted in writing, having been
